148th Semi Annual Executive Council Meeting: May 5, 2016

Dr. Frederick Lacey called the 148th Semi-Annual Executive Council meeting to order at 4:31 PM

Nicole Bruster did roll call. Dr.'s Brian Blanchard, Pamela Bouton, Leo Cacciotti, Betsey Clark, John Comisi, Richard Dunn, Robert Duthie, Payam Goudarzi, Frederick Lacey, Mario Silvestri, were present.

A motion to accept the minutes from the previous Executive Council as written was unanimously passed.

President's report- Dr. Frederick Lacey gave a brief overview of his report.

Treasurer's Report- Dr. Brian Blanchard reviewed the Budget for 2017, approved by the Budget Committee.

Component Share program was discussed.

A motion to eliminate the Component Share program line item from the Budget was passed unanimously

A motion to allow any Components to petition for grant money for any special interest they may have was passed with 1 abstention

Old Business

-Hospitality Suite was discussed again as a possibility. It was agreed that Dr. Frederick Lacey would take over the arrangements for the Hospitality Suite.

-Ms. Nicole Bruster updated the Executive Council on bill pay, and the credit card.

-Dr. John Comisi has taken over as Program Chair from Dr. Stuart Rouff

Budget

-President's CD- Dr. Perna recommended that we increase the amount that we put into the CD by \$500.00 per year.

A motion to raise the amount placed into the President's CD by \$500.00 per year was passed with zero abstentions

-Dr. Frederick Lacey recommended putting together a subcommittee to research a possible dues increase. Dr. Mario Silvestri volunteered to help research the subject.

New Business

-**Alternate Delegate to the House of Delegates:** Due to a deficit budget it was recommended that the Executive Council eliminate sending 1 of our Alternate Delegates to the ADA meeting, and only sending the Trustee and our two Delegates.

Proposed Bylaws Change:

A motion to send only the Trustee as our Alternate Delegate to the ADA meeting, and eliminate sending the 2nd Alternate Delegate, the Vice-President, in order to help correct the deficit budget of the Sixth District Dental Society was passed with 9 votes for the motion and 2 against it.

This motion will have to be brought to the Executive Council again at their next meeting held at the Owego Treadway on October 12, 2016, as well as presented to the membership 30 days prior to the meeting online at www.6dds.org.

Dr. Mario Silvestri will draw up a template for this motion to be placed in the bulletin.

-**Length of Meetings:** The suggestion was made to eliminate the two day meetings in the fall.

Dr. Lacey asked Dr. Comisi to research ways to get our members to our meetings, and report back in the fall.

-**Freshy Sites:** The handouts will no longer be available in print. They will be available as a downloadable attachment or link, which will be sent to attendees once they have registered for the course.

-**Honorary Membership:** Beth Wanek of NYSDA has been a terrific resource to the Sixth District and to Dr. Perna, and he recommended that we offer her an honorary membership.

A motion to offer Honorary Membership to Beth Wanek was unanimously passed

The Council on Peer Review and Quality Assurance

The Council on Peer Review and Quality Assurance met on Friday, April 1, 2016 at NYSDA.

The following are a summary of the issues that were discussed:

Education and Outreach

The council members were pleased with the three workshops that took place in Albany, Rochester and Queens. I attended this workshop as well as, Dr. Clark-Lowell and Dr Marusich, committee members. The council discussed the possibility of creating a training video that could be shared online. This would allow the members to become more familiar with the member benefit and service.

Escrow Payments

The council again discussed escrow requirements. The council wanted to put a resolution together that would no longer leave it up to the component's discretion to require escrow of a dentist, unless it was a multi-dentist practice, in which case escrow would be required. The resolution was not submitted as of last meeting, to the House of Delegates. After further discussion, a motion was made to amend the previous resolution to eliminate all escrow requirements for dentists, except with respect to requesting an appeal of a decision to the NYSDA Council on Peer Review and Quality Assurance. Accordingly, the resolution was approved to be submitted for consideration by the House of Delegates.

The council scheduled its next meeting on Friday, October 14 at NYSDA.

I would again like to thank our committee members and Sixth District staff for their effort.
